MESSAGE FROM THE PRESIDENT

Just over a year ago, 450 implementation enthusiasts gathered in Glasgow, Scotland for the 2019 Implementation Conference. After a full day of pre-conference masterclasses, the conference was opened with a reception for delegates in Glasgow's historic and ornate City Chambers, with the songs of a Scottish balladeer, a welcome from Glasgow's Lord Provost, and bagpipes to send us off with colleagues for dinner throughout the Centre City. Implementation researchers, practitioners, and policy makers, from around the world, connected with people for whom implementation is an area of significant interest or deep passion.

The world has shifted since then. Many of us have experienced more than six months of restrictions, limiting our "normal lives." Most of us have settled into new ways of working and connecting that comply with physical distancing. And as expected, with disruption, comes creation. We are finding new and innovative ways to continue with our implementation research, our implementation practice, and our implementation learning.

Across the membership of the Global Implementation Society, we are hearing about creative responses to 'doing implementation' under Covid-19 conditions. We have members who are enhancing their teaching, coaching, and data collection, as they make more effective use of virtual technologies. We also have members reaching out to 'thought partners' for guidance and strategies to support sustainment of implementation efforts in the midst of political and social turmoil.

As a global organisation, we are learning how to make better use of virtual technologies to bring us together for learning and thinking and acting is a priority. Members are engaged in various ways to share work and learning, to connect and seek perspectives to identify new solutions, and to contribute to the Society and the field of implementation science.

GIS is hosting its first Global Virtual Event on May 3-6, 2021! The Global Implementation Conference (GIC) is one of the world's leading implementation conferences. Hosted biennially by the GIS, the conference aims to promote implementation science, practice, and policy and their active application in human services to contribute to socially significant benefits to people and society.

The theme for this conference is **ADDRESSING EQUITY IN IMPLEMENTATION: Building Capacity in Research, Practice and Policy Across the Globe**. We are currently finalizing a dynamic list of invited speakers for panelists and workshop leaders. Our hope is to maximize participation from across the globe and highlight the breadth and depth of implementation research, practice, and policy work that is creating impact in diverse fields, such as social work, mental health, education, public health, and medicine. GLOBAL IMPLEMENTATION SOCIETY - LATIN AMERICA INITIATIVE

In an effort to strengthen implementation science, across the global south, GIS has begun to create Regional Networks in Latin America, Africa and Asia. The first virtual networking event occurred on August 25th, 2020 with 101 participants from 13 Latin American countries. The keynote speaker was Dr. Dean Fixsen who presented on the adaptation and fidelity dimensions using examples related to the COVID-19 pandemic. The next step for the Latin American network (GIS LATAM) is to meet in November to work through plans on how to establish a regional GIS initiative using inputs from the August event. Current themes include the characterization of Latin American practices, policies and research informed by implementation science, context specific factors for adapting evidence-based programs, how to address participatory methodologies for community engagement and capacity building throughout the region. It is also important to mention that as part of the GIS-LATAM initiative there is a new "special interest group in south to south collaboration". MEMBER RESOURCE

The GIS Competencies and Standards Committee has recently released the [GIS Competencies for Implementation Facilitators](#). The competencies can be used to self-assess strengths and weaknesses in five key domains:

1. knowledge about evidence-based intervention and implementation methods
2. diagnosis and data analysis
3. implementation teams
4. building relations and motivation
5. facilitating change

The competencies were developed to help those in low resource settings at the start of their implementation experience ("beginner") as well as for "intermediate" and "more expert" implementation facilitators. The competencies can be used by multiple stakeholders such as managers recruiting staff to facilitate implementation, developers of programs and courses for practical implementers, and funding agencies needing to understand the capacities necessary for innovation implementation. A webinar on the competencies will be held December 4 from 10:00-11:30 am EST.
